





ASSEMBLE PENDANT.


Place the pendant shade on a soft surface and thread the support tube on as shown.



ATTACH MOUNTING BRACKET.

- 1. Disconnect power.
- 2. Attach mounting bracket to ceiling electrical box as shown using the provided hardware.



HARDWIRE PENDANT.


- 1. Cut pendant cord to desired length, allow 4" above canopy for wiring.
- 2. Twist matching copper wires together.
 - -white to white
 - -black to black
 - -green to green
- 3. If no green wire (ground wire) is present in electrical box, wrap wire around pre-attached screw on mounting bracket and tighten into place.





ATTACH CANOPY TO BRACKET.

- 1. Align vertical holes on mounting bracket with side canopy holes.
- 2. Attach as shown using the provided hardware.
- 3. Re-connect power.

Additional Information

USE

This unit is meant for indoor use in dry locations only.

CLEAN

Clean powder-coated units with a soft cloth or sponge using a mild detergent, such as dish soap, and warm water. Wipe completely dry with a soft cloth.
